## ANNUAL REPORT / RAPPORT ANNUEL

The Quality of Policing Committee has continued to oversee the enhancement of reporting to the CRPA and Key Performance Indicators (KPIs) have been reported as part of the Officer in Charge report throughout the year. The CRPA web-site has been utilized to provide more information to all stakeholders thereby enhancing accountability and transparency to stakeholders.

## Accomplishments include:

**Key Performance Indicators** and objectives have been reported quarterly as part of the Officer in Charge report which is available on the CRPA Website. For 2018 these include:

- Percentage of citizens who feel safe in the Codiac region:
  - The 2019 Community Survey indicated 93% of residents felt safe in their neighborhood (target 85%) with results similar to two years ago.
- Road Safety:
  - Objective: Decrease number of non-fatal traffic collisions
    - Target: Below four-year average rate of 279 traffic collisions per 100,000 population
    - The 2018 result is 260
  - Objective: Increase Road Safety through strategic enforcement of drug and alcohol impaired drivers
    - Target: Below the 4-year average of 5.7 impaired driving offenses per 100,000 population. Outcome 6.2 versus a target of 5.7
  - o Increase in driving initiatives by the patrol section may have led to a higher rate in 2018.
- Property Crime & Fraud Files:
  - Objective: Make the Codiac region an even safer place to live and work by reducing property crime
  - Target: To reduce the number below the 4-year average of 5,624 or less. The 2018 result was 7428. A change in reporting of financial- fraud related calls occurred in Q2 of 2017. CRA and other phone-based technology scams are now included leading to increases in the number of property crime and fraud files. The revised target of 7459 includes the adaptation to factor financial/fraud calls in accordance the new reporting methodology.

Staffing adequacy and the impact on staffing and costs of both the Event center and the Cannabis Legislation were reviewed

The Board Championship Program was established to champion projects that add value to community safety and that encourage innovation and change in alignment with the strategic priorities of the Codiac RCMP. A subcommittee has been created composed of two (2) members of the RCMP; two (2) CRPA board members; and Charles Savoie.

The Officer in Charge Report was reviewed and revisions are underway to:

- inform the Board and the communities of specific activities the Codiac RCMP the report.
- report on themes such as a breakdown of POPA stats, good news stories, staffing levels and challenges, what policing looks like today, etc.
- create a better understanding of staffing challenges and contributions the CRPA can make to assist with solutions.
